Semi-invariant warped product submanifolds of cosymplectic manifolds

Abstract

In this article, we obtain the necessary and sufficient conditions that the semi-invariant submanifold to be a locally warped product submanifold of invariant and anti-invariant submanifolds of a cosymplectic manifold in terms of canonical structures T and F . The inequality and equality cases are also discussed for the squared norm of the second fundamental form in terms of the warping function.

1 Introduction

Bishop and O'Neill [1] introduced the notion of warped product manifolds in order to construct a large variety of manifolds of negative curvature. Later on, the geometrical aspects of these manifolds have been studied by many researchers (c.f., [2-5]). The idea of warped product submanifolds was introduced by Chen [6]. He studied warped product CR-submanifolds of the form $M = M_{\perp} \times_{\lambda} M_T$ such that M_{\perp} is a totally real submanifold and M_T is a holomorphic submanifold of a Kaehler manifold \bar{M} and proved that warped product CR-submanifolds are simply CR-products. Therefore, he considered the warped product CR-submanifolds in the form of $M = M_T \times_{\lambda} M_{\perp}$ which are known as CR-warped products where M_T and M_{\perp} are holomorphic and totally real submanifolds of a Kaehler manifold \bar{M} , respectively.

The warped product submanifolds of cosymplectic manifolds was studied by Khan et al [7]. Recently, Ateken studied warped product CR-submanifolds of cosymplectic space form and obtained an inequality for the squared norm of the second fundamental form [2]. In this article, we obtain some basic results of semi-invariant submanifolds of cosymplectic manifolds and prove that a semi-invariant submanifold M of a cosymplectic manifold \bar{M} is locally a Riemannian product if and only if the canonical structure T is parallel. The semi-invariant warped product submanifolds are the generalization of locally Riemannian product submanifolds, so it will be worthwhile to study warped product submanifolds in terms of canonical structures T and F , to this end we obtain some characterization results on the warped product semi-invariant submanifolds in terms of the canonical structures T and F .

2 Preliminaries

A $(2m + 1)$ -dimensional C^∞ -manifold \bar{M} is said to have an *almost contact structure* if there exist on \bar{M} a tensor field ϕ of type $(1, 1)$, a vector field ξ and 1-form η satisfying:

$$\phi^2 = -I + \eta \otimes \xi, \phi(\xi) = 0, \eta \circ \phi = 0, \eta(\xi) = 1. \quad (2.1)$$

There always exists a Riemannian metric g on an almost contact manifold \bar{M} satisfying the following conditions

$$g(\phi X, \phi Y) = g(X, Y) - \eta(X)\eta(Y), \eta(X) = g(X, \xi) \quad (2.2)$$

where X, Y are vector fields on \bar{M} .

An almost contact structure (ϕ, ξ, η) is said to be *normal* if the almost complex structure J on the product manifold $\bar{M} \times R$ is given by

$$J(X, f \frac{d}{dt}) = (\phi X - f\xi, \eta(X) \frac{d}{dt})$$

where f is the C^∞ -function on $\bar{M} \times R$ has no torsion i.e., J is integrable. The condition for normality in terms of ϕ, ξ and η is $[\phi, \phi] + 2d\eta \otimes \xi = 0$ on \bar{M} , where $[\phi, \phi]$ is the Nijenhuis tensor of ϕ . Finally, the fundamental two-form Φ is defined by $\Phi(X, Y) = g(X, \phi Y)$.

An almost contact metric structure (ϕ, ξ, η, g) is said to be *cosymplectic*, if it is normal and both Φ and η are closed [8], and the structure equation of a cosymplectic manifold is given by

$$(\bar{\nabla}_X \phi)Y = 0 \quad (2.3)$$

for any X, Y tangent to \bar{M} , where $\bar{\nabla}$ denotes the Riemannian connection of the metric g on \bar{M} . Moreover, for cosymplectic manifold

$$\bar{\nabla}_X \xi = 0. \quad (2.4)$$

Let M be a submanifold of an almost contact metric manifold \bar{M} with induced metric g and if ∇ and ∇^\perp are the induced connections on the tangent bundle TM and the normal bundle $T^\perp M$ of M , respectively. Denote by $\mathcal{F}(M)$ the algebra of smooth functions on M and by $\Gamma(TM)$ the $\mathcal{F}(M)$ -module of smooth sections of a vector bundle TM over M , then the Gauss and Weingarten formulae are given by

$$\bar{\nabla}_X Y = \nabla_X Y + h(X, Y) \quad (2.5)$$

$$\bar{\nabla}_X V = -A_V X + \nabla_X^\perp V \quad (2.6)$$

for each $X, Y \in \Gamma(TM)$ and $V \in \Gamma(T^\perp M)$, where h and A_V are the second fundamental form and the shape operator (corresponding to the normal vector field V) respectively, for the immersion of M into \bar{M} . They are related by

$$g(h(X, Y), V) = g(A_V X, Y), \quad (2.7)$$

where g denotes the Riemannian metric on \bar{M} as well as on M . The mean curvature vector H on M is given by

$$H = \frac{1}{n} \sum_{i=1}^n h(e_i, e_i)$$

where n is the dimension of M and $\{e_1, e_2, \dots, e_n\}$ is a local orthonormal frame of vector fields on M . The squared norm of the second fundamental form is defined as

$$\|h\|^2 = \sum_{i,j=1}^n g(h(e_i, e_j), h(e_i, e_j)).$$

For any $X \in \Gamma(TM)$, we write

$$\phi X = TX + FX, \quad (2.8)$$

where TX and FX are the tangential and normal components of ϕX , respectively.

Similarly, for any $V \in \Gamma(T^\perp M)$, we write

$$\phi V = tV + fV, \quad (2.9)$$

where tV is the tangential component and fV is the normal component of ϕV . The covariant derivatives of the tensors T and F are defined as

$$(\bar{\nabla}_X T)Y = \nabla_X TY - T\nabla_X Y \quad (2.10)$$

$$(\bar{\nabla}_X F)Y = \nabla_X^\perp FY - F\nabla_X Y \quad (2.11)$$

for all $X, Y \in \Gamma(TM)$.

Let M be a Riemannian manifold isometrically immersed in an almost contact metric manifold \bar{M} , then for every $x \in M$ there exist a maximal invariant subspace denoted by D_x of the tangent space $T_x M$ of M . If the dimension of D_x is same for all values of $x \in M$, then D_x gives an invariant distribution D on M .

A submanifold M of an almost contact metric manifold \bar{M} is called a *semi-invariant submanifold* if there exist on M a differentiable distribution D whose orthogonal complementary distribution D^\perp is anti-invariant, i.e.,

$$(i) \quad TM = D \oplus D^\perp \oplus \langle \xi \rangle$$

$$(ii) \quad D \text{ is an invariant distribution}$$

$$(iii) \quad D^\perp \text{ is an anti-invariant distribution i.e., } \phi D^\perp \subseteq T^\perp M.$$

A semi-invariant submanifold is *anti-invariant* if $D_x = \{0\}$ and *invariant* if $D_x^\perp = \{0\}$ respectively, for every $x \in M$. It is a *proper semi-invariant submanifold* if neither $D_x = \{0\}$ nor $D_x^\perp = \{0\}$, for each $x \in M$.

Let M be a semi-invariant submanifold of an almost contact metric manifold \bar{M} . Then, $FT_x M$ is a subspace of $T_x^\perp M$ such that

$$T_x^\perp M = FT_x M \oplus v_x \quad (2.12)$$

where v is the invariant subspace of $T^\perp M$ under ϕ .

Let M be a proper semi-invariant submanifold of an almost contact metric manifold \bar{M} , then for any $X \in \Gamma(TM)$, we have

$$X = P_1 X + P_2 X + \eta(X)\xi, \quad (2.13)$$

where P_1 and P_2 are the orthogonal projections from TM to D and D^\perp , respectively. It follows immediately that

$$(a)TP_2 = 0, (b)FP_1 = 0, (c)t(T^\perp M) = D^\perp, (d)fT^\perp M \subseteq \nu. \quad (2.14)$$

From (2.3), (2.5), (2.6), (2.8), and (2.9), we have

$$(\bar{\nabla}_X T)Y = A_{FY}X + th(X, Y) \quad (2.15)$$

$$(\bar{\nabla}_X F)Y = fh(X, Y) - h(X, TY) \quad (2.16)$$

for any $X, Y \in \Gamma(TM)$.

Definition 2.1 A semi-invariant submanifold M is said to be a locally semi-invariant product submanifold if M is locally a Riemannian product of the leaves of distributions D , D^\perp , and $\langle \xi \rangle$.

Definition 2.2 Let (N_1, g_1) and (N_2, g_2) be two Riemannian manifolds with Riemannian metrics g_1 and g_2 , respectively, and λ be a positive differentiable function on N_1 . Then the warped product of N_1 and N_2 is the Riemannian manifold $(N_1 \times N_2, g)$, where

$$g = g_1 + \lambda^2 g_2.$$

The warped product manifold $(N_1 \times N_2, g)$ is denoted by $N_1 \times_\lambda N_2$. If U is any vector field tangent to $M = N_1 \times_\lambda N_2$ at (p, q) , then

$$\|U\|^2 = \|\pi_1 U\|^2 + \lambda^2(p) \|\pi_2 U\|^2,$$

where π_1 and π_2 are the canonical projections of M onto N_1 and N_2 , respectively.

Bishop and O'Neill [1] proved the following results:

Theorem 2.1 Let $M = N_1 \times_\lambda N_2$ be a warped product manifold. If $X, Y \in \Gamma(TN_1)$ and $Z, W \in \Gamma(TN_2)$, then

- (i) $\nabla_X Y \in \Gamma(TN_1)$
- (ii) $\nabla_X Z = \nabla_Z X = \left(\frac{X\lambda}{\lambda}\right)Z$,
- (iii) $\nabla_Z W = \nabla_Z^{N_2} W - \frac{g(Z, W)}{\lambda} \nabla \lambda$.

where ∇^{N_2} is the connection on N_2 and $\nabla \lambda$ is the gradient of the function λ and is defined as

$$g(\nabla \lambda, U) = U\lambda, \quad (2.17)$$

for each $U \in \Gamma(TM)$.

Corollary 2.1 On a warped product manifold $M = N_1 \times_\lambda N_2$, we have

- (i) N_1 is totally geodesic in M ,
- (ii) N_2 is totally umbilical in M .

3 Some basic results on semi-invariant submanifolds

In the following section, we discuss some basic results on semi-invariant submanifolds of a cosymplectic manifold for later use. First, we obtain the integrability conditions of involved distributions in the definition of a semi-invariant submanifold and then we will see the geometric properties of their leaves.

Proposition 3.1 [9] Let M be a semi-invariant submanifold of a cosymplectic manifold then the anti-invariant distribution D^\perp is integrable.

Proposition 3.2 *The invariant distribution D on a semi-invariant submanifold of a cosymplectic manifold is integrable if and only if*

$$g(h(X, \phi Y), \phi Z) = g(h(\phi X, Y), \phi Z)$$

for each $X, Y \in \Gamma(D)$ and $Z \in \Gamma(D^\perp)$.

Proof. The result can be obtained by making use of (2.2), (2.3), and (2.5). ■

Proposition 3.3 *If the invariant distribution D on a semi-invariant submanifold M of a cosymplectic manifold \bar{M} is integrable, then its leaves are totally geodesic in M if and only if*

$$h(U, Y) \in \Gamma(\nu),$$

for each $U \in \Gamma(TM)$ and $Y \in \Gamma(D)$.

Proof. From (2.16), we obtain

$$F\nabla_U Y = fh(U, Y) - h(U, TY),$$

for any $U \in \Gamma(TM)$ and $Y \in \Gamma(D)$. Taking the inner product with ϕZ for any $Z \in \Gamma(D^\perp)$, we get

$$g(F\nabla_U Y, \phi Z) = -g(h(U, TY), \phi Z).$$

The result follows from the above equation. ■

Now, we have the following corollary for later use.

Corollary 3.1 *The invariant distribution D on a semi-invariant submanifold M of a cosymplectic manifold \bar{M} is integrable and its leaves are totally geodesic in M if and only if*

$$(\bar{\nabla}_X T)Y = 0.$$

for any $X, Y \in \Gamma(D)$.

Proof. The result follows from (2.15) and Proposition 3.3. ■

Lemma 3.1 *For a semi-invariant submanifold M of a cosymplectic manifold \bar{M} , the leaf N_\perp of D^\perp is totally geodesic in M if and only if*

$$g(h(X, Z), \phi W) = 0,$$

for any $X \in \Gamma(D)$ and $Z, W \in \Gamma(D^\perp)$.

Proof. From (2.2), (2.3), (2.5), and (2.6), we obtain

$$g(\nabla_Z W, \phi X) = g(h(X, Z), \phi W).$$

Thus, the result follows from the above equation. ■

Theorem 3.1 *A semi-invariant submanifold M of a cosymplectic manifold \bar{M} is locally a semi-invariant product if and only if*

$$(\bar{\nabla}_U T)V = 0,$$

for any $U, V \in \Gamma(TM)$.

Proof. If T is parallel then by (2.15), we have

$$A_{FV}U = -th(U, V) \tag{3.1}$$

for any U, V tangent to M . In particular, if $X \in \Gamma(D)$, then (3.1) gives, $th(U, X) = 0$, that is,

$$A_{FZ}X = 0. \quad (3.2)$$

for any $Z \in \Gamma(D^\perp)$. Thus by Proposition 3.2 and Lemma 3.1, D is integrable and the leaf N_\perp of D^\perp is totally geodesic in M . Let N_T be a leaf of D , now for any $X, Y \in \Gamma(D)$ and $Z \in \Gamma(D^\perp)$ by (3.2), we obtain $g(A_{\varphi Z}X, Y) = 0$ and using (2.2), (2.3), (2.5), and (2.6), we get $g(\nabla_X \varphi Y, Z) = 0$, which shows that leaf of D is totally geodesic in M and distribution $\langle \xi \rangle$ is already totally geodesic in M and hence M is locally a semi-invariant product.

Conversely, if M is locally a semi-invariant product then $\nabla_U \xi \in \Gamma(D)$ for any $X \in \Gamma(D)$ and $U \in \Gamma(TM)$, thus by (2.15) and the Proposition 3.3, we get $(\bar{\nabla}_U T)Y = 0$. Similarly, for any $Z \in \Gamma(D^\perp)$ and $U \in \Gamma(TM)$, we obtain $\nabla_U Z \in \Gamma(D^\perp)$ and then by (2.10), we get $(\bar{\nabla}_U T)Z = 0$ and it is easy to see that $(\bar{\nabla}_U T)\xi = 0$. By these observations we find that $(\bar{\nabla}_U T)V = 0$, for all $U, V \in \Gamma(TM)$, this proves the theorem completely. ■

4 Semi-invariant warped product submanifolds

Throughout this section, we denote N_T and N_\perp the invariant and anti-invariant submanifolds of a cosymplectic manifold \bar{M} , respectively. The warped product semi-invariant submanifolds of a cosymplectic manifold \bar{M} are denoted by $N_\perp \times_\lambda N_T$ and $N_T \times_\lambda N_\perp$. The first type of warped products do not exist of a cosymplectic manifold in the sense of [5], here we discuss the second type of warped products and obtain some interesting results. First, we have the following lemma:

Lemma 4.1 *Let $M = N_T \times_\lambda N_\perp$ be a warped product semi-invariant submanifold of an almost contact metric manifold \bar{M} . Then*

$$(\bar{\nabla}_Z T)X = (TX \ln \lambda)Z$$

$$(\bar{\nabla}_U T)Z = g(P_2 U, Z)T(\nabla \ln \lambda).$$

for any X, Z , and U tangent to N_T, N_\perp , and M , respectively.

Proof. Let $M = N_T \times_\lambda N_\perp$ be a warped product submanifold of invariant and anti-invariant submanifolds of an almost contact metric manifold \bar{M} , then by Theorem 2.1 (ii), we have

$$\nabla_X Z = \nabla_Z X = (X \ln \lambda)Z \quad (4.1)$$

for $X \in \Gamma(TN_T)$ and $Z \in \Gamma(TN_\perp)$. Then, from (2.10) and (4.1), we get

$$(\bar{\nabla}_Z T)X = (TX \ln \lambda)Z,$$

which proves the first part of the lemma. Now, for any $U \in \Gamma(TM)$, we have $TU \in \Gamma(TN_T)$, therefore $(\bar{\nabla}_U T)Z \in \Gamma(TN_T)$ for any $U \in \Gamma(TM)$. Furthermore, for any $X \in \Gamma(TN_T)$, we obtain

$$g((\bar{\nabla}_U T)Z, X) = -g(Z, \nabla_U TX).$$

Using (2.13), the above equation reduced to

$$\begin{aligned} g((\bar{\nabla}_U T)Z, X) &= -g(Z, \nabla_{P_1 U + P_2 U + \eta(U)\xi} TX) \\ &= -g(Z, \nabla_{P_2 U} TX) + \eta(U)g(\nabla_\xi Z, TX). \end{aligned}$$

Using (4.1), the second term of right hand side is identically zero, then the above equation takes the form

$$\begin{aligned} g((\bar{\nabla}_U T)Z, X) &= -g(Z, \nabla_{P_2 U} TX) \\ &= -(TX \ln \lambda)g(Z, P_2 U). \end{aligned}$$

Using (2.17), we obtain

$$g((\bar{\nabla}_U T)Z, X) = g(T\nabla \ln \lambda, X)g(Z, P_2 U).$$

That is,

$$(\bar{\nabla}_U T)Z = T(\nabla \ln \lambda)g(Z, P_2 U).$$

This proves the lemma completely. ■

Theorem 4.1 *A proper semi-invariant submanifold of a cosymplectic manifold \bar{M} is locally a warped product semi-invariant submanifold if and only if*

$$(\bar{\nabla}_U T)V = (TV\mu)P_2 U + g(P_2 U, P_2 V)\phi\nabla\mu, \quad (4.2)$$

for each $U, V \in \Gamma(TM)$ and μ , a C^∞ -function on M satisfying $W\mu = 0$, for each $W \in \Gamma(D^\perp)$.

Proof. Let $M = N_T \times_\lambda N_\perp$ be a warped product semi-invariant submanifold of a cosymplectic manifold \bar{M} , then from (2.10) and (2.13), we have

$$(\bar{\nabla}_U T)V = (\bar{\nabla}_U T)P_1 V + (\bar{\nabla}_U T)P_2 V + \eta(U)(\bar{\nabla}_U T)\xi.$$

Again using (2.10) and (2.13), the above equation takes the form

$$(\bar{\nabla}_U T)V = (\bar{\nabla}_{P_1 U} T)P_1 V + (\bar{\nabla}_{P_2 U} T)P_1 V + (\bar{\nabla}_U T)P_2 V. \quad (4.3)$$

Now, from Lemma 4.1, we have

$$(\bar{\nabla}_{P_2 U} T)P_1 V = (TV \ln \lambda)P_2 U$$

and

$$(\bar{\nabla}_U T)P_2 V = g(P_2 U, P_2 V)T(\nabla \ln \lambda).$$

Substituting these values in (4.3), we obtain

$$(\bar{\nabla}_U T)V = (TV\mu)P_2 U + g(P_2 U, P_2 V)\phi\nabla\mu.$$

Conversely, suppose that M is a semi-invariant submanifold of a cosymplectic manifold \bar{M} and (4.2) holds, then $(\bar{\nabla}_X T)Y = 0$, for each $X, Y \in \Gamma(D)$. Then by Corollary 3.1, D is integrable and each leave N_T of D is totally geodesic in M . Moreover, from (4.2), we have

$$g((\bar{\nabla}_Z T)X, W) = (TX\mu)g(Z, W).$$

for $X \in \Gamma(D)$ and $Z, W \in \Gamma(D^\perp)$. Using (2.3), (2.8), and (2.10), we obtain

$$g(\phi \bar{\nabla}_Z X, W) = (TX\mu)g(Z, W).$$

That is,

$$g(\bar{\nabla}_Z X, \phi W) = -(TX\mu)g(Z, W).$$

Using cosymplectic character and (2.5), we derive

$$g(\nabla_Z W, \phi X) = -(TX\mu)g(Z, W).$$

By (2.17), the above equation takes the form

$$g(\nabla_Z W, \phi X) = g(T\nabla\mu, X)g(Z, W). \quad (4.4)$$

Let us assume that N_\perp is a leaf of D^\perp and h' is the second fundamental form of the immersion of N_\perp into M , then

$$g(h'(Z, W), X) = g(\nabla_Z W, X).$$

Using (4.4), we get

$$g(h'(Z, W), \phi X) = -g(\nabla\mu, \phi X)g(Z, W)$$

or,

$$h'(Z, W) = -g(Z, W)\nabla\mu.$$

This means that N_\perp is totally umbilical in M with non vanishing mean curvature $\nabla\mu$. Also, as $W\mu = 0$, for all $W \in \Gamma(D^\perp)$, i.e., the mean curvature vector of N_\perp is parallel and the leaves of D^\perp are extrinsic spheres in M . Hence from a result of Hiepko [10], the submanifold M is locally a warped product semi-invariant submanifold of N_T and N_\perp with warping function $\lambda = e^\mu$. ■

Note. Theorem 4.1 is a generalization of Theorem 3.1, and shows that what is the effect on $\bar{\nabla}_T$, when the submanifold is a warped product semi-invariant submanifold.

Theorem 4.2 *A semi-invariant submanifold M of a cosymplectic manifold \bar{M} is locally a warped product semi-invariant submanifold if and only if*

$$g((\bar{\nabla}_U F)V, \phi W) = -(P_1 V\mu)g(U, W), \quad (4.5)$$

for $U, V \in \Gamma(TM)$ and $W \in \Gamma(D^\perp)$, where μ is a C^∞ -function on M such that $Z\mu = 0$, for all $Z \in D^\perp$.

Proof. If $M = N_T \times_\lambda N_\perp$ is a warped product semi-invariant submanifold of a cosymplectic manifold \bar{M} , then N_T and N_\perp are totally geodesic and totally umbilical in M , respectively. Moreover, we have

$$\nabla_X Z = \nabla_Z X = (X \ln \lambda)Z. \quad (4.5.1)$$

for any $X \in \Gamma(D)$ and $Z \in \Gamma(D^\perp)$. Now, by (2.13), we have

$$\begin{aligned} (\bar{\nabla}_U F)V &= (\bar{\nabla}_{P_1 U + P_2 U + \eta(U)\xi} F)V \\ &= (\bar{\nabla}_{P_1 U} F)V + (\bar{\nabla}_{P_2 U} F)V + \eta(U)(\bar{\nabla}_\xi F)V. \end{aligned}$$

Again, using (2.13), the above equation takes the form

$$\begin{aligned}(\bar{\nabla}_U F)V &= (\bar{\nabla}_{P_1 U} F)P_1 V + (\bar{\nabla}_{P_1 U} F)P_2 V + \eta(V)(\bar{\nabla}_{P_1 U} F)\xi + (\bar{\nabla}_{P_2 U} F)P_1 V \\&+ (\bar{\nabla}_{P_2 U} F)P_2 V + \eta(V)(\bar{\nabla}_{P_2 U} F)\xi + \eta(U)(\bar{\nabla}_\xi F)P_1 V \\&+ \eta(U)(\bar{\nabla}_\xi F)P_2 V + \eta(U)\eta(V)(\bar{\nabla}_\xi F)\xi.\end{aligned}$$

In view of (2.4), (2.5), and (2.16), the above equation reduced to

$$(\bar{\nabla}_U F)V = (\bar{\nabla}_{P_1 U} F)P_1 V + (\bar{\nabla}_{P_1 U} F)P_2 V + (\bar{\nabla}_{P_2 U} F)P_1 V + (\bar{\nabla}_{P_2 U} F)P_2 V.$$

Taking the inner product with ϕW , for any $W \in \Gamma(D^\perp)$, we obtain

$$\begin{aligned}g((\bar{\nabla}_U F)V, \phi W) &= g((\bar{\nabla}_{P_1 U} F)P_1 V + (\bar{\nabla}_{P_1 U} F)P_2 V \\&+ (\bar{\nabla}_{P_2 U} F)P_1 V + (\bar{\nabla}_{P_2 U} F)P_2 V, \phi W).\end{aligned}$$

Using (2.14), (2.16) and the fact that $P_1 U \in \Gamma(D)$ and $P_2 U \in \Gamma(D^\perp)$, for any $U \in \Gamma(TM)$, then the above equation becomes

$$\begin{aligned}g((\bar{\nabla}_U F)V, \phi W) &= g(fh(P_1 U, P_1 V), \phi W) - g(h(P_1 U, TP_1 V), \phi W) \\&+ g(fh(P_1 U, P_2 V), \phi W) + g(fh(P_2 U, P_1 V), \phi W) \\&+ g(fh(P_2 U, P_2 V), \phi W) - g(h(P_2 U, TP_1 V), \phi W).\end{aligned}$$

From (2.2), the above equation becomes

$$g((\bar{\nabla}_U F)V, \phi W) = -g(h(P_1 U, TP_1 V) + h(P_2 U, TP_1 V), \phi W).$$

Using (2.5), we derive

$$g((\bar{\nabla}_U F)V, \phi W) = -g(\bar{\nabla}_{P_1 U} \phi P_1 V, \phi W) - g(\bar{\nabla}_{P_2 U} \phi P_1 V, \phi W).$$

Using the covariant differentiation property of ϕ and the fact that $P_1 V \in \Gamma(D)$ and $P_2 V \in \Gamma(D^\perp)$, for any $V \in \Gamma(TM)$, then from (2.2), we obtain

$$g((\bar{\nabla}_U F)V, \phi W) = g(P_1 V, \bar{\nabla}_{P_1 U} W) - g(\bar{\nabla}_{P_2 U} P_1 V, W).$$

Again using (2.5), we arrive at

$$g((\bar{\nabla}_U F)V, \phi W) = g(P_1 V, \nabla_{P_1 U} W) - g(\nabla_{P_2 U} P_1 V, W).$$

The first term of right-hand side is zero by (4.1) and the fact that $P_1 V \in \Gamma(D)$ and $W \in \Gamma(D^\perp)$, thus we obtain

$$\begin{aligned}g((\bar{\nabla}_U F)V, \phi W) &= -(P_1 V \ln \lambda)g(P_2 U, W) \\&= -(P_1 V \ln \lambda)g(U, W) \\&= -(P_1 V \mu)g(U, W).\end{aligned}$$

Conversely, suppose that M is a semi-invariant submanifold of a cosymplectic manifold satisfying (4.5), then it is easy to see that

$$g((\bar{\nabla}_X F)Y, \phi W) = 0,$$

for each $X, Y \in \Gamma(D)$ and $W \in \Gamma(D^\perp)$. Thus, by (2.16) we obtain

$$g(h(X, \phi Y), \phi W) = 0.$$

Therefore by Propositions 3.2 and 3.3, the distribution D is integrable and its leaves are totally geodesic in M . Now for any $Z \in \Gamma(D^\perp)$, by (4.5), we have

$$g((\bar{\nabla}_Z F)X, \phi W) = -(X\mu)g(Z, W).$$

Using (2.16), we get

$$g(h(\phi X, Z), \phi W) = (X\mu)g(Z, W). \quad (4.6)$$

Let N_\perp be a leaf of D^\perp and h' be the second fundamental form of the immersion of N_\perp into M and ∇' is the induced connection on N_\perp , then by Gauss formula, we have

$$\nabla_Z W = \nabla'_Z W + h'(Z, W). \quad (4.7)$$

Now for any $Z, W \in \Gamma(D^\perp)$ and $X \in \Gamma(D)$, by (2.3) and (2.5), we have

$$g(h(Z, X), \phi W) = g(\phi X, \nabla_Z W).$$

From (4.7), we obtain

$$g(h(Z, X), \phi W) = g(h'(Z, W), \phi X). \quad (4.8)$$

Thus, by (4.6) and (4.8), we derive

$$g(h'(Z, W), X) = -(X\mu)g(Z, W).$$

Using (2.17), we obtain

$$h'(Z, W) = -g(Z, W)\nabla\mu,$$

which implies that N_\perp is totally umbilical in M with non vanishing mean curvature vector $\nabla\mu$. Moreover, as $Z\mu = 0$ for all $Z \in \Gamma(D^\perp)$ that is, the mean curvature is parallel on N^\perp , this show that N_\perp is extrinsic sphere. Hence, from a result of [10], M is locally a warped product submanifold. ■

Proposition 4.1. *Let $M = N_T \times_\lambda N_\perp$ be a warped product semi-invariant submanifold of a cosymplectic manifold of \bar{M} . Then*

- (i) $h_{\phi D^\perp}(\phi X, Z) = (X \ln \lambda)\phi Z$
 - (ii) $g(h(\phi X, Z), \phi h(X, Z)) = ||h_v(X, Z)||^2$
- for any $X \in \Gamma(D)$ and $Z \in \Gamma(D^\perp)$.

Proof. For any $X \in \Gamma(D)$ and $Z \in \Gamma(D^\perp)$, by Gauss formula, we have

$$h(\phi X, Z) = \phi \nabla_Z X + \phi h(X, Z) - \nabla_Z \phi X.$$

Using (4.1), we get

$$h(\phi X, Z) = (X \ln \lambda)\phi Z + \phi h(X, Z) - (\phi X \ln \lambda)Z. \quad (4.9)$$

Equating the tangential components of (4.9), we get

$$(\phi X \ln \lambda)Z = th(X, Z),$$

Taking the inner product with $W \in \Gamma(D^\perp)$, we obtain

$$g(h(X, Z), \phi W) = -(\phi X \ln \lambda)g(Z, W),$$

or equivalently

$$h_{\phi D^\perp}(X, Z) = -(\phi X \ln \lambda) \phi Z.$$

Replacing X by ϕX , we obtain

$$h_{\phi D^\perp}(\phi X, Z) = (X \ln \lambda) \phi Z,$$

which proves the part (i) of proposition. Now, for the second part comparing the normal components of (4.9), we get

$$h(\phi X, Z) = (X \ln \lambda) \phi Z + \phi h_v(X, Z),$$

or,

$$h(\phi X, Z) - \phi h_v(X, Z) = (X \ln \lambda) \phi Z,$$

Taking the inner product with $\phi h(X, Z)$, we derive

$$g(h(\phi X, Z), \phi h(X, Z)) = \|h_v(X, Z)\|^2,$$

which completes the proof. ■

Theorem 4.3. *Let $M = N_T \times_\lambda N_\perp$ be a warped product semi-invariant submanifold of a cosymplectic manifold \bar{M} . Then*

(i) *The squared norm of the second fundamental form satisfies*

$$\|h\|^2 \geq 2q \|\nabla \ln \lambda\|^2,$$

where $\nabla \ln \lambda$ is the gradient of the function $\ln \lambda$ and q is the dimension of N_\perp .

(ii) *If the equality holds identically, then N_T is a totally geodesic submanifold of \bar{M} , N_\perp is a totally umbilical submanifold of \bar{M} and M is minimal.*

Proof. Let $\{X_1, X_2, \dots, X_p, X_{p+1} = \phi X_1, \dots, X_{2p} = \phi X_p, X_{2p+1} = \xi\}$ be a local orthonormal frame of vector fields on N_T and $\{Z_1, Z_2, \dots, Z_q\}$ a local orthonormal frame on N_\perp . Then by definition of squared norm of mean curvature vector

$$\begin{aligned} \|h\|^2 &= \sum_{i,j=1}^{2p+1} g(h(X_i, X_j), h(X_i, X_j)) \\ &\quad + \sum_{i=1}^{2p+1} \sum_{r=1}^q g(h(X_i, Z_r), h(X_i, Z_r)) \\ &\quad + \sum_{r,s=1}^q g(h(Z_r, Z_s), h(Z_r, Z_s)) \end{aligned} \quad (4.10)$$

or,

$$\|h\|^2 \geq \sum_{i=1}^{2p} \sum_{r=1}^q g(h(X_i, Z_r), h(X_i, Z_r)).$$

In view of Proposition 4.1 (i), we get

$$\begin{aligned}\|h\|^2 &\geq \sum_{i=1}^{2p} \sum_{r=1}^q (\phi X_i \ln \lambda)^2 g(Z_r, Z_r), \\ &\geq 2q \|\nabla \ln \lambda\|^2.\end{aligned}$$

This verifies the assertion (i). If the equality sign holds, then from (4.10) and Proposition 4.1 (i), we get

$$h(D, D) = 0, \quad h(D^\perp, D^\perp) = 0 \quad \text{and} \quad h(D, D^\perp) \in \Gamma(\phi D^\perp). \quad (4.11)$$

As N_T is a totally geodesic submanifold of M , the first condition of (4.11) implies that N_T is totally geodesic in \bar{M} . Moreover, N_\perp is totally umbilical in M , the second condition of (4.11) implies that N_\perp is totally umbilical in \bar{M} , and also it follows from (4.11) that M is minimal in \bar{M} . ■
